IRDAI vide circular IRDAI/F4I/CIR/INV/216/08/2020 dated August 21, 2020 has permitted to classify investments in equity shares as a part of 'Approved Investment' if such shares have paid dividend 'for at least 2 years out of 3 consecutive years immediately preceding' instead of 'for at least 2 consecutive years immediately preceding' as required under Regulation 3(a)(4) and 3(a)(5) of IRDAI Investment Regulations, 2016. Accordingly, the Company has updated classification of equity shares for the purpose of investment limit monitoring and investment forms submission to the IRDAI w.e.f. October 1, 2020. However, securities are classified in the investment schedules as per the revised criteria specified in the circular dated August 21, 2020.
