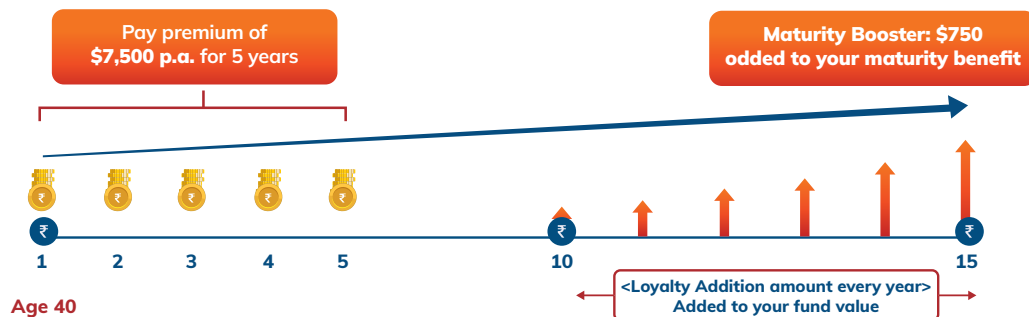
Illustration 1 - Growth Plan

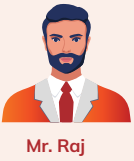

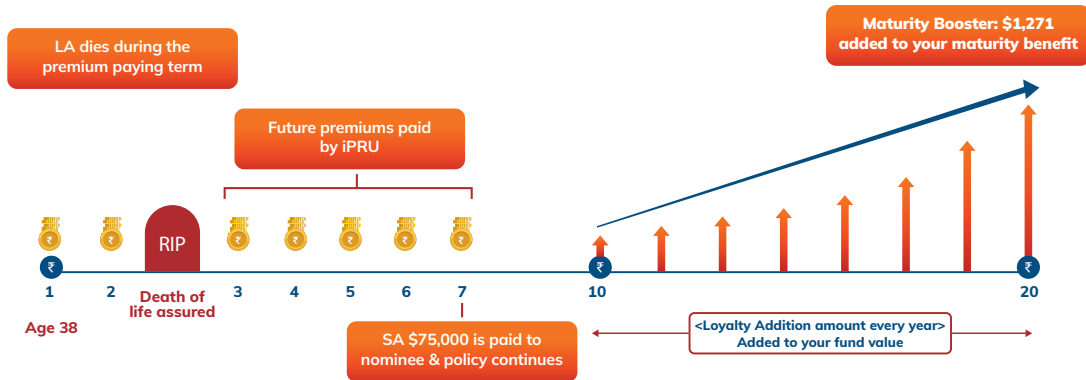
