3. Get the Life Verification Certificate and Photo ID attested by any one of the following:
  - a. Post Master
  - b. Principal of School / College
  - c. Bank Manager
  - d. Employee of ICICI Prudential Life Insurance Co. Ltd.
  - e. Present / Last Employer (Submit separate declaration on the Company Letterhead, confirming employment)
4. PAN/Form 60
